1. PURPOSE

The purpose of this memorandum is to request for approval to advertise the project on an RFQ (Request for quotations) for construction of a side walk cover as per below mentioned specifications. The project was budgeted for and it is a capital budget.

2. SCOPE OF WORKS FOR CONSTRUCTION OF THE SIDE WALK COVER

- 2.1. There are two portions at civic centre building that requires construction of side walk cover. One site has a distance of 23000 x 2500 mm wide and another side has a total distance of 25000 x 4300 mm distance.
- 2.2 The appointed service provider must excavation in all material for square tubing posts (200 x 200 x 600 mm height) x 18 = 0.432 m3
- 2.3. Supply, work and place a minimum of 25Mpa concrete mix for post foundation for concrete palisade fence.
- 2.4 Supply and erect square tubing at 3 m apart centre to centre at height of 2400mm above the ground surface.
- 2.5 The square (120 x 120 square tubing) for the Post and the cross bar and the lip Channel (100 x 50 mm) must be painted in golden brown colour.
- 2.6 Supply and Install the IBR Roof sheeting (2.491 x 23 m) and (4.288 x 25 m) using tap screw with cover cap.
- 2.7 The thickness of the steel square tubing must be 2mm thickness.
