Lephalale Local Municipality must comply with the Water use license. The municipality is experiencing challenges with the handling of sewer which results to regular directives from the Department of Water and Sanitation.

Sanitation division is struggling with the installation of pumps due to shortage of pump sliding shoes to name few, and this leads to sewer spillages, some pump stations being operated on a bypass line system and overtime hours being too high due to frequent checks on pump stations. The aim is to install two pumps per pump station, one duty one standby; minimize sewer spillages and overtime hours.
