BACKGROUND

The wireless network offers the Municipality a flexible way for devices to communicate with each other, enabling seamless connectivity without the need for physical network cables, by utilizing radio waves. Wireless networks transmit data between devices through routers, allowing users to access the internet, share files, and communicate wirelessly. It will allow users to move freely while still connected to the network. Now users can leave their office to attend meetings and still be able to connect wirelessly to the Municipal network without any challenges, for so long as they are within reach of the installed Access Points.

Signals for both MTN & Vodacom is very poor in the Lephalale Local Municipality Council Chambers and the surrounding offices and that makes it very difficult for councilors to work when in the Council Chambers.

CHALLENGES.

The office space in the Municipality is one of the main challenges, and users are therefore forced to share offices with only one network point. IT office has to always improvise by using Hubs to enable those users.
