MUNICIPAL NOTICE**

ANNUAL REPORT 2016/2017

In terms of the Section 127 (2) of the MFMA the Mayor must within 7 months after the end of a financial year, table in the Municipal Council the Annual Report of the Municipality. No discussion on the Annual Report will take place at that meeting. The Mayor of Lephalele Municipality tabled the Annual Report for 2016/2017 in an Ordinary Council Meeting held at 12h00 on Thursday, **25 January 2018**.

In terms of Section 21A of the Local Government Municipal Systems Act, 32 of 2000, and in terms of Section 127(5) a (ii) of the Municipal Finance Management Act, 56/2003 (MFMA) the Accounting Officer of the Municipality must, thereafter make the Annual Report public and invite the local community to submit representations in connection with the Annual Report immediately after the Annual Report was tabled in the Council. That means that the Annual Report for 2016/2017 will be available at the Office of the Municipal Manager, Satellite Offices, Thusong Centres and Traditional Leader's Offices from Thursday, **01 February 2018**.

The meeting of the Council where an Annual Report is to be discussed or resolutions concerning the Annual Report are to be taken must be open to the local community and time be allowed for the discussion of the written * *submissions* received from the public and also allowed time for members of the local community to address the Council as determined in Section 130 (1) a and b of the MFMA. This meeting will take place on Thursday, **27 March 2018**.

In terms of Section 129 (1) of the MFMA the Council must within 2 months after the Mayor has tabled the annual report 127(5) took place, adopt an oversight report on the Annual Report containing the Council's comments on the Annual Report and whether the Annual Report is approved/rejected/send back and the Accounting Officer must within 7 days thereafter, in terms of Section 129 (3) MFMA and Section 21A of the Systems Act, again make the oversight report available to the public.
