PUBLIC NOTICE: INDIGENT REGISTRATION FOR FINANCIAL YEAR 2026/2027

Residents are hereby informed that Lephalale Municipality will be conducting an Indigent Registration Programme for qualifying households within its jurisdiction. The purpose of this programme is to provide relief to indigent households that are unable to afford basic municipal services.

Who qualifies:

Households with a combined monthly income below the prescribed threshold of **R4600** are encouraged to apply.

Registration Requirements:

Applicants are required to bring the following documents:

- Certified copy of ID (Applicant and spouse, if applicable)
- Proof of income (e.g. payslip, affidavit if unemployed, or SASSA confirmation)
- Recent Municipal account (if applicable)
- Proof of resident.

28 April 2026 till 30 September 2026

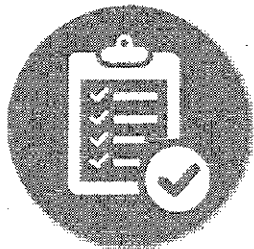

- You must only have one property
- O tshwanetse go nna le bodulo bo le bongwe
