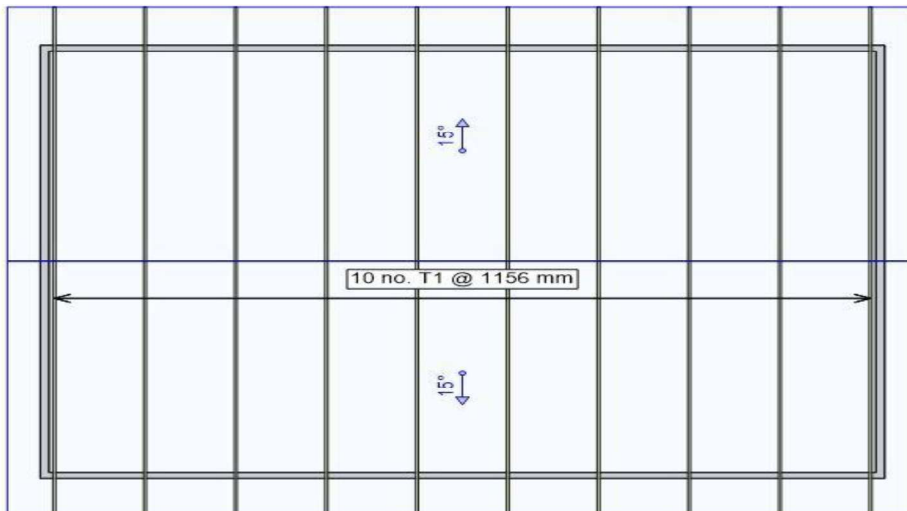
The Municipality invites suitably qualified and experienced contractors to submit quotations/tenders for:

“Supply, delivery and installation of timber roof trusses, roof structure, bracing and 0.5 mm IBR roof covering at the Pump House.”

The works include supply, delivery and installation of timber roof trusses, installation of purlins and bracing, installation of IBR roof sheeting, flashings, ridge capping, fixings, waterproofing and all associated works necessary to provide a complete and functional roof.

5. TIMBER ROOF TRUSSES

Timber roof trusses shall:

- Be manufactured from suitable structural-grade timber.
- Be appropriately treated.
- Be fabricated accurately.
- Be structurally designed for the actual building.
- Be installed at the spacing indicated by the approved design.
- Be securely connected to the supporting structure.
- Include all necessary bracing.

- Be free from defects that could compromise structural performance.

Timber shall not be used if it is excessively warped, split, decayed or otherwise unsuitable for structural use

6. PURLINS

Purlins shall be:

- Properly aligned;
- Correctly spaced;
- Securely fixed;
- Adequately supported; and
- Adequately braced.

7. BRACING

The roof structure shall include all bracing necessary for structural stability.

This may include:

- Top chord bracing;
- Bottom chord bracing;
- Longitudinal bracing;
- Lateral bracing;
- Diagonal bracing; and

8. ROOF SHEETING

Roof sheeting shall be:

0.5 mm IBR profile metal roof sheeting, or an approved equivalent of equal or superior performance.

The contractor shall supply and install:

- Roof sheets;
- Roofing screws;
- Washers;
- Side-lap fixings;
- Ridge capping;
- Flashings;
- Closures where required;
- Sealants; and
- All accessories required for a watertight installation.

Sheets shall be installed in accordance with the manufacturer's installation requirements.

9. WATERPROOFING

All roof joints, penetrations, flashings and interfaces shall be properly sealed.

The completed roof shall be watertight under normal weather conditions.

Any leakage attributable to poor workmanship shall be rectified by the contractor at no additional cost to the Municipality.

10. SAFETY

The contractor shall comply with all applicable occupational health and safety requirements.

The contractor shall provide, where applicable:

- Safety file;
- Health and Safety Plan;
- Risk assessments;
- Method statements;
- Fall protection measures;
- Scaffolding/access equipment;
- Personal protective equipment;
- Safe lifting procedures;
- Working-at-height controls;
- Competent persons;
- First-aid arrangements; and
- Emergency procedures.

11. WORKING AT HEIGHT

Because roof construction involves work at height, the contractor shall provide suitable fall-prevention and fall-protection systems.

No worker shall be permitted to work at height without the required safety controls.

12. QUALITY CONTROL

The contractor shall ensure that:

- Materials comply with the specification.
- Timber is suitable for structural use.
- Trusses are correctly fabricated.
- Connections are secure.
- Bracing is correctly installed.
- Roof sheets are correctly aligned.
- Roofing screws are correctly installed.
- Flashings are correctly installed.
- The roof is watertight.
- Construction waste is removed.

The Municipality may inspect the works at any stage.

13. MATERIAL APPROVAL

The contractor shall submit material/product information to the Municipality for approval before installation where requested.

Where a specific product is referenced, equivalent or superior products may be proposed subject to approval.

14. DEFECTS LIABILITY

The contractor shall rectify defects attributable to defective workmanship or materials within the applicable defects liability period stipulated in the contract.

The Municipality may require the contractor to correct defects at no additional cost where such defects arise from failure to comply with the specification.

15. SPECIAL CONDITIONS

The appointed service provider shall comply with the Occupational Health and Safety Act and all applicable regulations.

- The service provider shall provide all labour, supervision, tools, equipment and machinery required to execute the works, including but not limited to scaffolding, step ladders, roofing tools, welding machines and any other equipment necessary for the successful completion of the project.
- The contractor shall ensure that all required safety signs, barricades and warning notices are erected before commencement of the works and maintained throughout the project.
- All materials required for the project shall be available on site before construction commences.
- The contractor shall maintain a clean and safe working environment at all times and shall remove all waste and surplus material upon completion of the works.
- All demolition rubble and waste material shall be transported and legally disposed of at the Grootegeeluk Landfill Site.
- The contractor shall be responsible for the security and safekeeping of all materials, tools and equipment on site.
- Tenderers shall possess a minimum **CIDB Grading of 1GB** or higher.
- The quoted price shall include all labour, transport, delivery, fuel, equipment, materials, overheads, profit and any other incidental costs necessary to complete the works.
