LEPHALALE MUNICIPALITY



1. BACKGROUND

Lephalale Local Municipality is situated North of West in Limpopo Province and it is under Waterberg District. The topographical area of Lephalale is relatively flat; hence the sewer system run with Pump Stations pumping to the Wastewater treatment works. Due to the Sewer line gradient that is relatively flat, Sewerage Pumps are placed over a short distance to boost the flow.

The pump stations are constructed along with the development around the Municipal area and draining to the nearest main sewer pump stations. Both the drainage pipes, pumping main and gravity lines vary in sizes.

The municipality is experiencing challenges with the handling of sewerage and compliance with regulations and green drop requirements which results in regular directives from the Department of water and Sanitation.

There is a need to refurbish the dilapidated pipeline in - order to minimize the operation and maintenance costs and that of managing the wastewater while minimizing the negative impacts on the environmental and human health.

2. LEGISLATIVE FRAMEWORK

3. OBJECTIVES OF THE CONTRACT

The Employer's objectives are to appoint a service provider.

3.1 The Contract is aimed to address the following aspects:

- a) To improve efficiency, functionality and to sustain the existing sewer infrastructure.
- b) To improve sanitation service delivery to the community of Lephalale.

4. EXISTING INFRASTRUCTURE

The bulk pumping main from pump station 12 to the nearest delivery manhole needs to be replaced due to collapsed/dilapidated pipeline. The pipeline is situated near Exxaro houses opposite TVET college and is approximately 200m long, with a diameter of 100mm. The sanitation division team repaired the pipeline umpteen times, hence the request to replace it.

5. THE PROPOSED SCOPE OF WORKS

- Supply, Installation and testing of a 160mm diameter Upvc Class 12 pipe with fittings, including connections to the manholes
- Emptying of pump station 12 for the duration of the project to relieve/alleviate sewer spillages/overflows for the nearby houses

6. CONDITIONS OF THE CONTRACT

- Only reputable service providers with relevant experience and capacity will be considered.

- The service providers' competency evidence to undertake such works should be clearly stated.
- The appointed service provider will only make use of qualified or competent personnel.
- Company profiles with references, curriculum vitae of the project teams and any professional registration documents must be submitted.
- All prices should include labor and travelling costs.
- All unused materials/parts should be given back to the municipality and be safely delivered to the municipal workshop.
- To furnish LLM with risk assessment, and health and safety plan prior commencement of works
- Responsible for the health and safety of their employees as per the standard.
- The Contractor shall make it a point that they have all the necessary signage for such kind of a project.
- CIDB grading shall be 1CE or higher.
