BACKGROUND

LLM recognizes the fact that unethical conduct, fraud and corruption within LLM is detrimental to good, effective, accountable and transparent governance within LLM and can endanger the economic stability of LLM and have the potential to cause social damage. LLM has therefore realised that there is a need for procedures in terms of which employees, businesses, stakeholders and the entire community may, without fear of reprisals, disclose information relating to suspected or alleged unethical conduct, fraud and corruption affecting LLM.

These complaints arise from a variety of sources. LLM has therefore seen the need to continuously have anonymous reporting mechanism for the receipt of these complaints.

2. SCOPE OF WORK

LLM invites service providers to submit Tender for the provision and management of a professional and ethical anonymous disclosure platform that will encourage LLM employees, and any other stakeholder, to report fraud, theft and/or any other irregularities within the organisation in a safe and harassment free environment.

The successful bidder will be responsible:

- 2.1 To provide and manage the anonymous reporting of dishonest, illegal and/or inappropriate activities, contraventions of codes of conduct, sexual harassment, racism, nepotism, bad driving etc. taking place at the LLM.
- 2.2 For the visible display of the range of communication channels which can be used for the disclosure of information which may be of interest to LLM.
- 2.3 For the timeous and regular reporting to LLM internal stakeholder of all irregularities disclosed.

- 2.4 Receive and analyse all claims of irregular activities with a strong ability to distinguish between legitimate claims and crank calls to avoid wasteful expenditure by the LLM.
- 2.5 Assist with the creation of a culture of awareness within the Municipality and maintaining it by conducting regular awareness campaigns. (web-based e-learning, video presentation clips, hardcopy booklets and pamphlets).
